National Academies of Science Report: Significant Barriers to Conducting Clinical Trials

- "One of my mantras on the committee was that the absence of evidence of effectiveness does not equate to evidence of the absence of effectiveness!"
- We were quite selective and stringent in reviewing only the highest quality clinical trials and restricted our grading of evidence by using the careful criteria that the committee agreed upon. This coupled with the significant barriers that exist to conducting clinical trials of the potential therapeutic benefit of the plant material leave us with a handful of strong conclusions on therapeutic benefits of cannabis. (Piomelli et al., 2017, quoting Dr. Abrams, panel member)."



The Dynamic Duo: THC and CBD

- Derivatives
- Differences in law and chemistry. At least recently . . .
- Delta-9-tetrahydrocannabinol (THC)
 - -Psychoactive
- Cannabidiol (CBD)
 - -Derived from both MJ and hemp
 - -Hemp by definition = 0.03% THC
- Extraction: It don't come easy

- FDA expressed concern that "the number of drug claims being made about products not approved by the FDA that claim to contain CBD or other cannabis-derived compounds.
- Among other things, the FDA requires a cannabis product (hemp-derived or otherwise) that is marketed with a claim of therapeutic benefit, or with any other disease claim, to be approved by the FDA for its intended use before it may be introduced into interstate commerce."[emphasis added]

FDA press release post 2018 FB

- "Additionally, it's unlawful under the FD&C Act to introduce food containing <u>added</u> CBD or THC into interstate commerce, or to market CBD or THC products as, or in, dietary supplements, regardless of whether the substances are hempderived.
- This is because both CBD and THC are active ingredients in FDA-approved drugs and were the subject of substantial clinical investigations before they were marketed as foods or dietary supplements."

- The insanity continues
- "More restaurants and facilities nationwide report they can't sell CBD anymore"
- "In the past week, enforcement letters and product seizures spread to new jurisdictions, a response to December comments from the U.S. Food and Drug Administration that CBD can't be put in foods or nutritional supplements until the molecule gets an updated review."

- Farm Bill's guarantee: "no state or Indian tribe shall prohibit the transportation or shipment of hemp or hemp products."
- Four men working for a hemp-transportation company . . . were charged with drug crimes for allegedly carrying some 18,000 pounds of Kentucky cannabis destined for a CBD manufacturer in Louisville, Colorado
 - -"We told them, 'We're hauling hemp, and here's our paperwork.' It was all there, certified by the state of Kentucky."
- An Oregon truck driver was arrested in Boise, Idaho, for carrying roughly 6,700 pounds of cannabis from Oregon to Big Sky Scientific, a CBD manufacturer in Aurora, Colorado
